## **Inform Strata Corporation**

4(3) Before an owner or landlord rents all or part of a residential strata lot, the landlord must give the prospective tenant: the current bylaws and a "Notice of Tenant's Responsibilities" in the prescribed form (Form K). An Owner or landlord must provide Strata Council (or Strata Manager) with a Form K signed by the tenant within 2 weeks of the beginning of the rental/tenancy. Anyone "house sitting" for one month or longer, constitutes a "rental" for the purposes of this bylaw.
